Neptune Code

After admission, all doctoral students will receive their Neptun code and login password in a personal letter or e-mail. If you forget your password, you should contact the Study Desk Officer.

Student ID Card

How to apply:

1. Preparation of IEC data sheet at a Document Office
 2. On the Neptun website interface, by choosing the doctoral program, you can start the Student ID Card application under the Administration tab
 3. In case of successful application, a temporary Student ID Card can be requested
 4. The completed Student ID Card can be picked up at the Registrar's Office of DSMS (the Study Desk Officer will notify the student about its completion in about 4-6 weeks)
- We would like to draw your attention to the character point filling in both the IEC data sheet and the Neptun website interface in order to make a successful application!

Student ID Card sticker

The stickers arrive in DSMS at about the end of the first month of the given semester. You will be notified of the sticker arrival by the Study Desk Officer of DSMS. Admission is possible during the study administration, only in person.

Certificate of student status

Issued by the Study Desk Officer of DSMS upon request by email. It is possible to issue both electronic and paper-based certificates.

GENERAL INFORMATION ON DOCTORAL TRAINING

Doctoral (PhD) training at the Ludovika UPS is conducted in accordance with Act CCIV of 2011 on Higher Education (hereinafter: Higher Education Act), in accordance with the requirements of Government Decree No. 387/2012 (XII.19.) on Doctoral Training and Degree Awards, and on the basis of the University Doctoral and Habilitation Regulation.

Classification of military science by discipline of science: Social Sciences

Branch of science: Military Sciences

Name of the doctoral degree awarded: Military Sciences (PhD)

Organized forms of doctoral training:

- full-time (full-time scholarship, self-financed);
- part-time (correspondence self-financed);
- individual training (self-financed);

Permissible form without training:

Individual preparation (self-financed): enters the training from the 3rd grade.

Duration of the doctoral training: 8 active semesters, during which at least 240 credits must be obtained

Stages of doctoral training:

- 1. "Training and research"** phase: four active semesters, during which the student participates in face-to-face teaching and also conducts scientific research work in connection with his/her dissertation. The completion of the stage is the successful completion of the complex exam.
During the 4 semesters, a minimum of 120 credit points must be completed as follows:
 - Minimum study obligation is 70 credits;
 - Scientific research at least 50 credits;
 - Teaching: maximum 10 credits during the entire training (not compulsory, but can be used to redeem the scientific credit value).
- 2. "Research and dissertation"** phase: the second four active semesters, during which there is no in-person teaching, the dissertation research work is completed. The completion of the phase is the issuance of the absolutorium. During the four semesters, 120 credits must be obtained, as follows:
 - Within the subject „Dissertation Research” 20 credits,
 - Scientific research at least 100 credits;
 - Teaching: maximum 10 credits during the entire training (not compulsory, but can be used to redeem scientific credit value).
- 3. Post-training phase:** one year. The doctoral student must submit his/her doctoral thesis within three years of the complex examination, i.e. after Phase 2, with the issuance of the absolutorium, the student's legal relationship is terminated and he/she has 1 year to start the degree acquisition procedure (2+2+(1) years).

Student status

Student status:

- The student status of a doctoral student is established by enrolment, or in the case of individual preparation, by the completion of the complex exam and by enrolment.
- From the second semester of their studies, doctoral students register in the Neptun system during the registration period, declaring whether they continue their studies or suspend their student status. If the doctoral student participating in the self-financed training continues his/her studies, he/she certifies the payment of the training fee at the same time as registration.

Continuous student status:

A doctoral student who fulfils the following conditions may have a continuous student status:

- enrolls in the first semester;
- in the following semesters, he or she announces the continuation of his or her studies and certifies the payment of the training costs;
- obtains a minimum of 21 credit points per semester (the distribution of credit points is regulated by the Study and Examination Regulation of UPS – SER UPS), this does not apply to participants in individual training.

The student status is continuous even if the student participates in a partial training course at a foreign or other Hungarian university for a longer period of time, where the partial tasks agreed with the supervisor are fully completed and can be assessed with credit points.

Suspension of student status (passivation):

The head of DSMS may authorise the suspension of the student status on a maximum of three occasions, for a total of four semesters. The first suspension can only take place after the successful completion of the first semester, with the exception of e.g. a suspension requested for medical reasons.

During the suspension of the student status, no state doctoral scholarship may be awarded, the doctoral student may not participate in the training, may not earn credit points, and shall not pay any training costs.

During the period of the suspension, the doctoral student may collect data, conduct scientific research, publish, participate in scientific conferences and tenders. The doctoral student may be credited for his/her activities during the period of suspension in the first active semester following the suspension. The scientific activities carried out in the passive semester must be indicated and certified in the Informative Data document required for the closing of the semester.

Termination of student status:

- with a written waiver submitted by the student after a decision of the Doctoral Council of the Discipline on the day of the announcement;
- at the student's request, by transferring to a doctoral programme at another university, on the day of acceptance;
- At the end of the training, at the same time as the acquisition of the absolution.

Termination of student status based on the unilateral decision of the Doctoral Council of the Discipline:

- fails to fulfil his/her academic and/or scientific research obligations set out in the Study and Examination Regulations on a pro rata temporal basis;
- if the doctoral student fails to pass the complex exam, on the day of failure or failure of the obligation, (SER UPS 32. §);
- on the basis of the assessment of the supervisor (if he/she considers that the student does not comply with the requirements of his/her research plan in his/her research work);
- fails to register before the start of the semester on two consecutive occasions due to the student's own fault;
- after the expiry of the deferral of the year granted to the student, he/she shall not start his/her studies in the next period of study.

Provided that the student has been called upon to comply with his/her obligation by the doctoral school in writing by the given deadline and has been informed of the legal consequences of the omission.

Semester Study Start

1. The academic semester begins with the registration and subject registration period, when the student sets their semester to active or passive status on the Neptun website interface . (In the first semester, this is done by the Study Desk Officer instead of the students.)
2. During this period, the mandatory subjects must also be added on the Neptun website interface. You can also see the subjects in the Model Curriculum in semester distribution on our website, and the Study Desk Officer will also send you the timetable in advance.
Every semester, DSMS also announces courses related to the subject of Scientific Research, which bear the names of the students' supervisors. Each student takes the course advertised in the name of their own supervisor (in the first semester, the Study Desk Officer takes all subjects).
3. Submission of a semester-long detailed study and research plan: Submitted by the student by the 1st day of the first month of each semester (1 September and 1 February), according to the sample document prescribed in Annex 1. This document contains, among other things, the freely chosen subject that the student would like to listen to during the semester in addition to his compulsory subjects.
The chosen subject is announced in NEPTUN each semester by the Study Desk Officer and admitted to the student. The student must contact the lecturer of the subject after the announcement and course registration. The subject always ends with a practical mark and is worth 2 credits.
4. Four-year individual study and research programme: On the basis of the prescribed study, research and examination obligations, the doctoral student, under the guidance of the supervisor, prepares 3 copies by the end of the last month of the first semester (31 January) in accordance with the sample document prescribed in Annex 2.

The study and research programme is approved by the head of the relevant research area on the basis of the proposal of the supervisor. This document only needs to be prepared and submitted once, in the first semester. (The individual trainee is not obliged to do so!)

Semester Closure

1. After fulfilling the requirements of the compulsory and elective subjects, the student checks whether the instructors have recorded the appropriate entry (signature, grade) on the Neptun interface. In case of absence, the student contacts the instructor of the subject, and they will settle the signatures and grades by the end of the exam period.

2. Filling in the Informative Data Document **required for the end of the semester** and submitting it to the DSMS /Annex 3/ <https://hdi.uni-nke.hu/english-documents/documents>

On the basis of the Informative Data Document, the subject of Scientific Research is closed. The subject of Scientific Research is a subject with moving credits, under which the scientific activity of the student completed during the semester is accounted for by the DSMS. In the document, the student must indicate all the scientific activities he or she has carried out in that semester. The student's supervisor gives the signature for this subject in Neptun, but the credit assigned to the scientific activity and the closing of the subject are based on the Information Document completed and submitted at the end of the semester. The scientific activities recorded in this document are supervised by the Scientific Secretary. After that, the Study Desk Officer records the appropriate credit value for the course, after which she closes the student's semester. The closure of the subject is done after the academic activity of the students has been verified, so it is a longer process. Regardless of this, the compulsory semester must be activated and the compulsory subjects must be enrolled.

Credits

During the entire duration of the training, i.e. by the end of the 8th active semester, a minimum of 240 credits must be achieved (plus a maximum of 10 percent can be booked on the Neptun interface, so the maximum of 264 credits can be achieved).

Accordingly, students can achieve **an average of 30-33 credits** in the semester distribution based on their performance.

Breakdown of the maximum credits that can be awarded during the semester:

- **study** credits, i.e. credits received after successfully completing subjects;
- **scientific** credits, i.e. credits accounted for under the subject of Scientific Research, this is a variable credit value, it is always determined for the scientific activity completed in the given semester on the basis of the credit value table /Annex 4/;
- **teaching** credits: it is not mandatory, but it can be used to redeem credits earned through scientific activity, up to a maximum of 10 credits during the training.

In general, in addition to study credits, it is possible to achieve the total credits that can be recorded for the semester on average, for example, by writing one scientific publication. Of course, it is possible for students to write several publications in one semester, but in terms of semester credit accounting, we can only record the credit value of one publication in Neptun. In this case, it is possible to settle the "surplus" publication written in the previous semester in the next semester, if no publication is made.

Counting preliminary performances

The results of scientific research work carried out in the three years immediately preceding admission to the doctoral school – related to the research topic of the doctoral student – **may be recognised with credit points in the doctoral programme according to the credit value table set out in Annex 4.** In case the preliminary performances are not related to the student's topic, 50% of the credit points can be awarded.

Only one scientific activity can be accounted for in the first semester of the training.

The recognition of credit points for scientific research work is decided by the Council of the Doctoral School at the student's request and with the agreement of the supervisor.

The application must be sent electronically to the Secretariat of the Doctoral School by 1 October after enrolment, and the original document must be submitted at the same time (Section 15 of the DSMS SER). <https://hdi.uni-nke.hu/english-documents/documents>

Academic activities (e.g. subjects studied) or teaching cannot be recognised as preliminary performance.

In the case of participants in individual training, the crediting of preliminary performances is not applicable.

Requirements for the fulfilment of the study obligation

In the field of study, in the Training and Research Phase, i.e. in the 1st to 4th semester, all doctoral students participating in organized training must take or choose subjects in the following order in the value of at least 70 credits (also compulsory for those in individual training, but can be completed according to an individual curriculum):

Admission of subjects: during the subject registration period of the given semester – about which the Study Desk Officer will provide information in advance – the student activates his/her semester on the Neptun website interface and enrolls the compulsory subjects of the given semester.

Compulsory subjects: In the 1st to 4th semesters, all doctoral students participating in organized training at the university are required to take the compulsory subjects determined by the Council of the Doctoral School for each academic year. By completing the compulsory subjects organized within the timetable, 62 credits can be obtained. The subjects are advertised by the Study Desk Officer on the Neptun website interface, and the student takes them during the subject registration period.

Elective subjects: In semesters 1st to 4th, one elective subject must be taken in each semester, if possible, in relation to the research topic, in the value of 2 credits per subject. A total of at least 8 credits can be obtained with elective subjects completed in each semester.

The list of elective, enrolable subjects and research seminars, together with the necessary other information, is published on the DSMS website. After consultation with the supervisor, the student chooses one from this list, which is indicated in the semester research plan. The Study Desk Officer then announces the course of the subject and picks up the subject for the student. The student is obliged to contact the instructor of the subject of their choice after the announcement of the subject.

The aim of the research seminar is to deepen the student's knowledge in the topic of the doctoral student's choice – related to the research topic. To search for and process the relevant literature, and to be able to form and synthesize an independent opinion on the topic. The seminar is evaluated and graded by the lecturer who announced the topic. The grade is entered into the schoolbook as a practical mark.

Research Workshop Seminar Subject: In the fourth semester, the doctoral student must take the subject, which prepares him/her for the complex exam. At the beginning of the fourth semester, doctoral students are informed about the requirements of the complex exam and how to prepare the research plan. At the end of the fourth semester, the doctoral students will give an account of their knowledge of the literature in their research topic at a seminar organized by the head of the research field, organized by research areas, and present their "Research Plan" for the Research and Dissertation phase. The student enrolls in the course advertised in the name of his/her area manager.

Individual training: A student who is unable to participate in the merging of subjects providing compulsory study due to a long-term absence (e.g. foreign service) may apply for an exemption from this (individual study schedule), i.e. he or she will be exempted from attending attendance classes. However, in this case, he/she must pass his/her exams during the exam period of the given semester and must meet the requirements necessary for the completion of the subject, which are determined by the instructor of the subject.

Requirements for the fulfilment of scientific research work

Scientific Research Subject:

In order to complete the scientific research work, the subject "Scientific Research" belonging to the given semester must be taken up in each semester. The Roman numerals after the subject indicate the semester in which the subject can be taken. The student can hold accountable for the scientific activities carried out in the given semester during this subject.

The credit values of the course can be changed individually in the NEPTUN system according to what the student has actually completed by the end of the semester. This means that the scientific activities and credit values communicated by the student in the semester Information Data document are entered into the Neptun system by the Study Desk Officer of the doctoral school after the control of the Scientific Secretary, and then the student's semester is closed.

The semester closure of this subject is a longer control and administration process, so in parallel, the student activates the next semester, takes his subjects and starts the semester!

Activities listed in the credit value table (Annex 4) can be accounted for as scientific research works, such as books, book chapters, journal articles, conference presentations, scientific applications, patents, etc.

Accounting for publications:

- Preparation and publication of a professional article every semester, which is related to one's own research.
- Publications that are not closely related to the research topic can only be accounted for in the 1st or 2nd semesters, and therefore only half of the credit value can be counted.
- If the student does not publish in the given semester, he or she must make up for it in the next semester, but he or she can only use this once.
- Professional publications are those with a minimum of 0.5 printing sheets in length and have been published in a journal classified in classes A, B, C, D by a department of the Hungarian Academy of Sciences and/or with a D or Q rating.
- In the journal search service of the Collection of Hungarian Scientific Works (MTMT) interface, the student can check the current classification of the given publication interface (journal).

- At the end of the semester, an authentic editorial acceptance statement must be attached to the Informative Data document next to submitted and revised but not yet published publications.
- A co-author statement must be attached to the publication written as a co-author, in which the participation rate must be recorded. The credit point shall be calculated on the basis of the participation rate, so that the fractional parts shall be rounded to whole points according to the general rules of rounding. An exception is the five-tenth, which must be rounded upwards.
- A publication published in a conference publication is understood to mean the full length of the conference presentation — possibly an abbreviated abstract — and not the outline of the presentation.

The same publication or scientific activity can only be counted once during the entire period of the training.

Obligation to hold lessons

- Teaching is an optional — and not mandatory — opportunity to earn credits. If the doctoral student does not undertake teaching activities, he/she may complete the 10 credit points available for teaching with scientific activity or study credits
- Doctoral students in a teaching position may not earn credit points at their own university, with taught classes.
- With the exception of those in individual training, credit points can only be completed from the 2nd semester.
- A doctoral student who wishes to earn credit points by teaching a lesson must take the subject "Education" belonging to the given semester from among the subjects outside the research fields.
- Classes may only be held with the permission of the head of the department responsible for the topic, from the student's research topic — or a topic area close to it.
- One credit can be credited for holding 4 lessons.
- A maximum of 10 credits can be earned during the eight semesters.
- The holding of the lesson is certified by the head of the department responsible for the topic.

Complex Exam

During the doctoral training, at the end of the fourth semester, as a condition for the completion of the training and research phase and as a condition for the start of the research and dissertation phase, a complex exam must be completed, which measures and evaluates the academic and research progress.

Conditions for admission to the complex exam:

1. Academic: obtain 120 credits and complete 4 subjects of your choice
2. Publication requirements: existence of 3 publications

Parts of the Complex Exam:

- a) theoretical part, during which the doctoral student gives an account of his/her knowledge of the relevant scientific literature and his/her current theoretical and methodological knowledge. In the theoretical part of the Complex Exam, the examinee takes an exam in two subjects and topics.
- b) an oral report on the progress of the student's scientific research with the help of a ppt. prepared on the basis of the "Research Plan and Report".

Schedule of preparation for the complex exam:

1. Uploading the published publications to the MTMT interface during the semesters.
2. Coordination of the "Research Plan and Report" document required for the Complex Exam with the supervisor, which also includes the schedule for the preparation of the dissertation and the publication of the results. Formal requirements: min. 1 printing sheet in length, Verdana font, font size 10, line spacing: multiple 1.15.
3. DSMS sends the Complex Exam preparation questions to students via email.
4. In accordance with the requirements of the subject of the Research Workshop Seminar, the student sends the "Research Plan and Report" document to the head of the research area, agreed upon in advance with the supervisor.
5. After the submission and verification of the Information Document, the student's academic semester will be closed.
6. The student sends the DSMS electronically in an e-mail with all the documents required for the application:
 - "Application for the Complex Exam" document:
https://en.uni-nke.hu/document/en-uni-nke-hu/APPLYING%20FOR%20THE%20COMPLEX%20EXAMINATION_2022.docx
 - "Supervisor evaluation
 - "Research plan and report" document: which the head of the research area and the supervisor have already seen in advance.
7. The DSMS will send the schedule for the complex exam to the student.

Research and dissertation phase

After a successful Complex Exam, the student enters the second stage of the training. There is no in-person teaching at this stage, the goal is continuous research and progress in the preparation of the dissertation. The completion of the phase is the issuance of the absolutorium. At this phase, 120 credits must be obtained during the four semesters, as follows:

- 20 credits within the framework of the Dissertation Research subject. Courses in the subject are advertised for the student's research area and the name of the area manager. At the end of each semester, the doctoral student reports on his or her research to the head of the research area in writing and orally, and in the case of a successful report, he or she may receive 5 credit points per semester.
- Scientific research work minimum 100 credits. The subject of Scientific Research will continue to be announced every semester, which measures the scientific activity of the student during the semester.
- Teaching maximum 10 credits during the entire training (not compulsory, but can be used to redeem academic credit value).

Individual students start their doctoral studies in this phase immediately after their admission.

Completion of the training – absolute

The final certificate – absolutorium – certifies the specific fulfilment of the prescribed study obligation, the requirements of scientific research and teaching lessons, the successful passing of the prescribed exams – except language exams –, and the acquisition of the credit points prescribed in the requirements.

Conditions for issuing the absolutorium:

- The final certificate (absolutorium) certifies the fulfilment of the requirements of the study obligation, scientific research and teaching (if chosen by the student) prescribed in the curriculum, the successful passing of the prescribed exams – except language exams –, and the acquisition of the 240 credit points prescribed in the requirements, which certifies without qualification or evaluation that the doctoral student has fulfilled the required training requirements in all respects.
- After the successful completion of the 8th semester, if all the conditions for issuing the absolute certificate are met, the doctoral school will issue the final certificate. However, the student will only receive this if he or she submits his or her own and the supervisor's 4-year summary report to the school: <https://hdi.uni-nke.hu/english-documents/documents>
- The condition for completing the absolutorium is the acquisition of 20 publication points, the existence of at least one publication in a foreign language and seven publications in Hungarian related to the doctoral student's research topic published during the period of the training in domestic and foreign classified journals ("A" or "B" or "C" category) determined by the Military Science Committee of the Hungarian Academy of Sciences (or other committees of the Hungarian Academy of Sciences). (/Publication Point Value Table /Appendix No. 5/). The existence of publications is checked from the MTMT interface.
- The four-year training period may not be shortened, the absolutorium may not be issued earlier, but the workshop discussion may be held in the last semester of the training, and the degree acquisition procedure may also be started.

The final certificate is signed by the head of the doctoral school in the doctoral student's transcript. On the day of completing and signing the absolutorium, the doctoral student's student status is terminated. From the acceptance of the application for the degree procedure until the date of the conferral of the doctorate, the candidate shall be entitled to the title of "submitter of the doctoral thesis".

Elements of the degree acquisition procedure

In order to obtain a PhD degree, a successful workshop is required.

The workshop discussion:

Before submitting the thesis, a workshop discussion must be conducted. The aim of the workshop discussion is to enable a professionally competent community that is well acquainted with the topic of the thesis to explore the shortcomings of the thesis, to confirm the values of the doctoral dissertation and to provide assistance in the development of the final dissertation in the best possible quality. The draft dissertation must be sent at least 15 days before the workshop discussion, and it must also be published on the DSMS website.

The public defence:

The doctoral thesis must be defended in a public debate in front of a jury. The dissertation can be posted after the two supporting evaluations have been received. The Doctoral Evaluation Committee is

a committee appointed by the Doctoral Council of the discipline to conduct the public discussion of the doctoral thesis, to decide on the acceptance of the thesis and to evaluate the public defence. The doctoral jury consists of seven members. The committee is headed by the chairman, its members are the secretary, the two official critics (opponents) and three members.

The submitter of the doctoral thesis receives the evaluations in advance, and answers the questions asked in them in writing before the public defence and orally at the defence.

The evaluation of the public defence of the doctoral thesis can be *summa cum laude*, *cum laude* or *rite*.

Language requirements for obtaining a PhD degree:

Proof of knowledge of two foreign languages. Proof of proficiency in two foreign languages, proof of at least one B2 and one B1 level (basic) complex language exam or equivalent certificate in the language specified in Article 22 (3) of the UPC UDHR is required. In the case of a complex state-recognised language exam (or equivalent certificate) at the level C1 (advanced), it is sufficient to certify a complex state-recognised language exam (or equivalent) at the B1 level (basic) in another language. (DSMS OR § 23)

Acceptance, change of supervisor, title and research topic

Students participating in doctoral training organised at another university may request admission to DSMS if the conditions for their research activities are provided and the credits (or a part thereof) obtained there can be credited to DSMS training. The Rules of Procedure for re-registration are laid down in the University Doctoral and Habilitation Regulations. During the transfer process, a committee decides on the receipt of credits, consisting of the scientific secretary, the head of the research area and the head of the given department.

The student may initiate a change of the topic or supervisor at the Doctoral Council of the Discipline. Before making its decision, the Council asks for the opinion of the head of the research area.

The title of the doctoral thesis may be changed at the request of the supervisor or the student, or at the suggestion of the workshop discussion, with the approval of the DCD.

Changing the topic can only be requested and allowed once in justified cases, in the 1st and 2nd semesters, which must be supported by a developed research topic plan.

All applications must be addressed to the Head of the Doctoral School through the Scientific Secretary. The Application form can be found on the website.

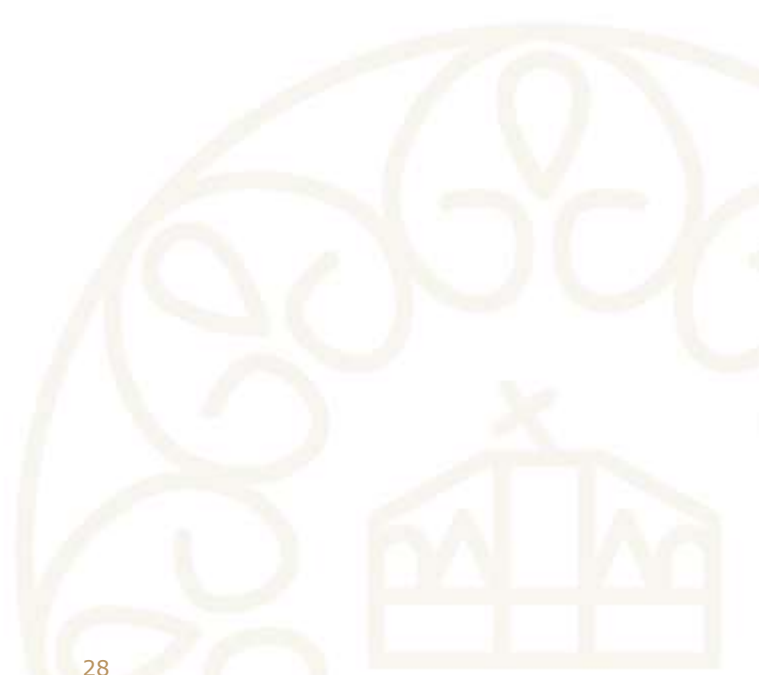
